





# Life's just grand in **prestigious Prahran**

A top property executive has paid close to eight figures for a spectacular inner-city mansion.



have a penchant for historic homes, forking out \$9.4 million for a trophy estate in Prahran's prestigious Grandview Grove.

The deal, for the six-bedroom, 1895 home, was struck just months after the businessman paid \$7.15 million for a Federation era domain in Clowes Street, South Yarra - which Warson relisted for sale this week.

At the start of a major property slowdown in 2008, Warson paid \$8.4 million for the unrenovated Coomaroo mansion in Toorak's Albany Road, profiting once the market improved more than a year later from subdividing the 2400-square-metre land parcel in three. The entrepreneur

A vacant 511-square-metre tract was listed for about \$2 million, while \$7.6 million was recovered selling the then renovated Coomaroo home, on a reduced 1294-squaremetre block. Like Albany Road, where the neighbours included transport tycoon Lindsay Fox and shopping-centre owner John Gandel, Grandview Grove has some BRWRich List residents, including members of the Kornhauser family. The Glenvill director's new Prahran home, on a 1676-square-metre parcel, also includes a swimming pool and tennis court. Among the company's biggest projects is Yarra Bend, which is replacing the Amcor Paper Mill factory site, in Alphington. MP

from Geelong, where he lives. Oakdene Estate, six stages of which have already been offered to the market, is covered by a single dwelling covenant, deterring unit and apartment builders from what is being marketed as a familyfriendly area. Developers occasionally employ celebrity ambassadors to differentiate their products. In 2008, Sydney-based former model Jodhi Meares was the "fashion and lifestyle collaborator" for R. Corporation's Clara complex, in South Yarra. Not long after, the sometimes foulmouthed chef Peter Russell-Clarke was used to promote Brunswick East's Elvira project. MP

### **Bey-hive**

An investor has paid \$2.8 million for four mezzanine-style studio apartments connected to a two-

storey commercial space, part of which is used by Bey Dance described as "a dance community dedicated to releasing the disco diva within onto the dance floor, full of flawless fabulousness, just like our hero, Queen Bey" (aka Beyonce Knowles). The portfolio is within a famous Brunswick building - the only Spanish Mission-style market building ever developed in Victoria. Barry Plant's Jason Padula represented the vendor who for years has operated a business from part of the building. MP
